## EU Chemicals Regulation EC 1907/2006 REACH and information requirements in the supply chain (Article 33 / SVHC)

We hereby declare that the fasteners supplied by us comply with the requirements of the REACH Directive (EU Chemicals Regulation EC 1907/2006 REACH).

In principle, REACH does not stipulate any requirements for the conformity of products or processes; accordingly, no conformity can be declared. For the most part, the REACH requirements only apply to chemical substances. The only requirement for products is the notification in the supply chain if a product contains more than 0.1% of a SVHC (Substance of very high concern). In this case, the customer must be informed which substance is contained in which concentration in which part of the product. If such a notification does not take place, it must be assumed that no SVHC are contained in the product. Regarding the "obligation to communicate information on substances in articles" described in Article 33 of the REACH Regulation and concerning us, we would like to inform you of the following:

As a manufacturer/distributor and/or importer of articles (fasteners, etc.), we take our obligations under the REACH regulations very seriously. Goebel GmbH assures to follow the updates of the REACH requirements, especially the extensions of the candidate list as well as the inclusion of substances in REACH annexes (Candidate List of Substances of Very High Concern for Authorization, REACH-Annex XIV), and to compare them with the substance information (see above).

The current list of candidates can be found on the ECHA website (http://echa.europa.eu/chem data/candidate list table en.asp).

Our suppliers of articles are obliged to inform us unsolicited and without delay if the products they deliver contain a SVHC substance above 0.1 percent by weight. Information that substances of the candidate list are contained in articles or packaging delivered by us above 0.1 percent by weight has been received from our suppliers in isolated cases. As soon as we find out that our products are subject to notification according to Art. 33, we will inform you without being asked.
